## **MESSAGE OF THE M.W. GRAND MASTER**

To the Members of the Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska.

I bid you welcome to the Twenty-Third Annual Communication of the Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska. Our annual sessions allow us to meet on the level and act on the square with our brethren from around Alaska and the world. For those of you who are her in Sitka and Southeast Alaska for the first time, I extend my sincere welcome to the banana belt of Alaska. It's interesting to note that Sitka is the oldest City on the west coast of North America and was once called the Paris of the Pacific. The history of Masonry in Alaska is synonymous with Sitka and the purchase of Alaska from Russia on October 18, 1867. The following spring or April 14, 1868, a dispensation was granted by the Grand Lodge of Washington to 14 Masons for a Lodge at Sitka which was eventually chartered as Alaska Lodge 14 on September 17, 1869.

## **APPOINTMENTS**

Most Worshipful Brother John H. Grainger, Very Worshipful Brother Russell H. Mills, Very Worshipful Brother William Goodwin were appointed to the Committee on Segregations and Reference.

Worshipful Brother William Kalbach was appointed Grand Orator replacing Worshipful Brother Marty Parsons.

## **NECROLOGY**

District 4 and this Grand Lodge lost an exemplary member with the passing of Very Worshipful Brother David Delong early this year. He was a member of Mt. Juneau-Gastineaux Lodge 21, past Deputy of the Grand Master, and was named Mason of the Year by Grand Master Steve Cox at the 22<sup>nd</sup> Annual Communication of the Grand Lodge of Alaska in Fairbanks in February 2003. May we cherish his memory forever.

The least desirable report is the Necrology Report and although it is the least desirable it is a report of love and sorrow. It is a time to remember those Brothers who have passed on before us. Our Grand Chaplain Worshipful Brother Roger K. Hansen will give this report later in the session. I would like to quote a paragraph from the Necrology report given by Past Grand Master Steve Cox in last years report that is thought provoking. "The scythe of time and the cold touch of death never ceases to take from us those we love. We can only try to live our lives in such a manner that we are living monuments to their sacred memory."

## **STATE OF THE CRAFT**

The state of the craft continues to be encouraging. Growth, the life blood of our organization still shows signs that it is continuing. I noted during my visitations that many of our Lodges had just conferred a degree or were scheduling degrees in the near future. Those few Lodges that had not conferred degrees recently, are the Lodges that I referred to as troubled Lodges in a report submitted at the Western Conference of Grand Masters three years ago. Last years Grand Master's Message showed a growth of two Lodges in our Jurisdiction, which was commendable. I must now report the pending loss of one of our Lodges. This loss, either with another Lodge or arresting of its Charter, has been oncoming for several years has just been done will be done shortly.

## **VISITATIONS**

During the year of 2003, I made the annual Official Visitation of the Grand Master to each Lodge in the Jurisdiction. I also the attended the Conference of Grand Masters in Minneapolis, MN, The Western Conference of Grand Masters in Seattle, WA, and the Grand Lodges of Oregon and Washington. I also visited the Lafayette Lodge #242 in Seattle attending its 75<sup>th</sup> anniversary. Visitations were made to various concordant Bodies

including Imperial Shrine in Minneapolis and other concordant Bodies within Alaska and the Lower 48.

### **SPECIAL ACTIONS OF THE GRAND MASTER**

The following EDICT was vacated to comply with an order of the Superior Court for the State of Alaska. Third Judicial District at Anchorage Case No., 3AN-020427e “Any Mason involved in a legal action against the Grand Lodge, or Grand Lodge Officer’s actions fro the Grand Lodge, will be immediately expelled from the Grand Lodge. Confirmation of the summary Expulsion will be taken at the Next Grand Lodge session and will require a two-third vote of the members attending. If the Expulsion is not upheld, the penalty will be lowered to Suspension for a time indefinite.” The ruling of the Superior Court stated “The powers of the Grand Master to suspend members and provisions of the April 1, 2002 Edict to cause the expulsion of members for filing lawsuits shall be reviewed in an open and representative process and shall be voted upon by the convened Grand Lodge in 2004”

This court also recommended that The Alaska Masonic Code be reviewed. This has been done.

Mt. Juneau-Gastineaux #21, September 03, permission granted to change date of Second Stated Communication from 16<sup>th</sup> to 23<sup>rd</sup> of September.

Mt. Verstovia #18, December 03, permission to change date of January 2004 Stated Communication from 1 January to 8 January 2004.

## **FINANCES OF THE GRAND LODGE**

Finances of the Grand Lodge continue to be a problem. Our per capita income has not been increased for several years and I am sure that you all are aware that our concordant bodies have increase their per capita assessments this year, to offset the increasing costs of operations. Yet when I mentioned increasing per capita I am told that the brothers will not stand for it. Brothers it is time to bite the bullet and do something while we still have a Grand Lodge.

1. Here are a few problems that your finance committee, Line Officers, and Grand Treasurer have been face with during this current year.
2. The cost of Insurance was almost doubled due to the liability claim that was settled last fall. We are expecting a further increase in premiums due to Insurance marketing conditions when the policy renews in July of this year.
3. An unbudgeted expense of \$5,000.00 for attorney fees to the above claim was paid.
4. The travel expense paid to the Line Officers was reduced three years ago in an effort to help reduce an unbudgeted expense of \$15,000.00 that we are faced with. This reduction in travel payment has not been returned to the budget and it should be. We cannot expect our Line Officers to continue paying travel expenses out of their own pockets.
5. Our publication "Light from the Great Land" has only been published once in the last two years. This was due to lack of funds in the budget to publish and mail the bulletin more than that one time. My brothers a Grand Lodge cannot be a viable organization if it unable to communicate with its members.

We were fortunate in that the Grand Treasurer found an overpayment in the amount of \$6,000.00 to a supplier which helped offset the additional expenses indicated above. We will not have that windfall this coming year.

Two weeks from now our Grand Lodge has the honor of displaying its history and Masonic information at the George Washington National Memorial in Washington D.C. We have no funds for this trip nor do we have funds to pay for the travel of our member on the board of directors of the Memorial. We expect them to represent us, at their own expense, this my Brothers is not right.

We need a paid employee in the Grand Lodge Office, on a part-time basis, to handle routine office duties and to assist the Grand Secretary.

My Brothers it is time to do something about this financial shortfall and I will cover that in my recommendations as follows.

### **RECOMMENDATIONS**

I recommend approval of an emergent resolution assessing every Lodge \$10.00 per Master Mason, due and payable by April 1, 2004. These funds to be a part of the operating budget for the 2004 – 2005 fiscal year.

I recommend that the current per capita of \$0.50 per member payable to the George Washington National Memorial be increased by \$0.50 to a total of \$1.00 per year.

I urge the immediate passage of Resolution 2004-2 for the good Masonry, and this Grand Lodge.

### **APPRECIATION**

I direct a special thank you to the following. First; to the Grand Secretary Most Worshipful Brother Les Little for the countless hours spent in traveling to and from his home in Sterling in the performance of his duties, and for the excellent job he has done as Grand Secretary these last two years. He has been a boon to me, ever ready to answer my countless questions and to assist me, when called upon.

To Right Worshipful Brother Jerry Fairley, Grand Treasurer of this Most Worshipful Grand Lodge. RW Bro. Jerry has spent untold hours manning the Grand Lodge Office on a volunteer basis. He is primarily responsible for bringing our financial records into order and setting up a new accounting system. He accepted without question the duty of being assigned a special Deputy to the Grand Master in the Anvil Lodge #2 problem and traveling there on my behalf.

Both of these Grand Lodge Officers are through this year and are not seeking re-election to these two positions. This Grand Lodge owes these Brothers a round of thanks for a job well done.

A thank you is extended to my Brothers in Mt. Verstovia Lodge #18 for their support, both emotionally and financially, for without it the path to today would have been almost impossible to travel.



Thanks also to my son Worshipful Bert K. Stedman, my sounding board, my critic, and supporter.

I would be remiss if I didn't thank my wife Bonnie for patience, understanding and support during these last four years, for without it I could not have reached this pinnacle of Masonry, Grand Master of the Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska.

## **CONCLUSION**

My Brothers, one year ago you bestowed me the greatest honor I have ever received, Grand Master of the Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska. I hope I have lived up to your expectations. I have tried to fulfill my duties with honor, integrity, and compassion. You have coming behind me Line Officers that I have been proud to serve with.

Right Worshipful Brother Joe Dees, Deputy Grand Master, has been a true and steady friend and a brother knowledgeable in our Craft. He will make an excellent Grand Master. Behind him you have Right Worshipful Harry Koenen and Marvin Fitzpatrick, two brothers of excellent character and well versed in Masonry. We have a wonderful Grand Jurisdiction with competent Line Officers to carry us into the future. Support them as you have supported me for the future is bright for you and our fraternity.

## **ANNUAL REPORT OF THE GRAND SECRETARY**

To the Most Worshipful Grand Lodge of Alaska, F. & A. M.

I herewith submit my report of the status of this Most Worshipful Grand Lodge.

We have encountered a large budget deficit this year due to the doubling of our insurance premiums. This was due to the legal action brought against this Grand Lodge by certain members of this Grand Lodge during the year 2001, and finally settled in the year 2002. We went from a cost for insurance of approximately \$8,000 to approximately \$15,000. This severe increase in premiums will never go away. Your Grand Master's message contained a recommendation for an assessment of \$10 per member. This is to help offset this budget deficit, as well as other expenses. I urge the approval of this recommendation.

We have continued to strive to reduce costs within the office of the Grand Secretary, and to increase the effectiveness of certain procedures.

We now are able to print the Alaska Masonic Code in house at a substantial savings. The cost to buy the new Code is not yet fully determined, but we expect it to be less than half the current cost of \$15.00. It will be in a new and much easier to read format. The Code will now be printed in the 8-1/2x11 format, and placed in a 3 ring binder. Subsequent changes can be printed and inserted at very little cost, instead of having to go to a p[rinter where we forced to order large minimum quantities. The index to the Code has been expanded to give you even more options to cross reference the Sections you are looking for. Many hours were put into this effort. The index was inadequate for a person to quickly locate the desired Sections. Suggestions for even more entries to the index are always welcome.

We also plan to incorporate the EA, FC, and MM booklets into the alternative proficiency manual. This will assist us in further saving of printing costs. These are not the ciphers, just the hand out degree booklets. There will not be any change to the cipher in the near future. We note, however, that the Grand Lodge of Washington has gone to an electronic version of the cipher. This may be something we can look at in the future.

To help make the job of the Lodge Secretaries even easier and less complicated, we have created a new web site specifically for the Lodge Secretaries to file their required monthly returns electronically if they so desire. The return is acknowledged so there are no questions about it being received in the office. This web site contains only the return form and should not be accessed by anyone except the secretary of the Lodge. This method of monthly reporting has been well received so far and we encourage more secretaries to avail themselves of these options.

R.W. Brother Gerald R. Fairley, our Grand Treasurer, has continually updated the database for all members. His diligence in transferring data from the old card system to the database has greatly eased the locating of records for individual Brothers whenever necessary. It is important that we continue to get the records of all Alaska Masons current and deceased, onto the database in order to help preserve the history of Masonry in Alaska. We maintain current copies in several locations outside the office so there is no danger of losing our data due to mishap.

It is imperative that we have a part time assistant to be in the office to take care of the day-to-day details, such as opening mail, answering letters, filing documents, answering the phone, responding to requests for information from other Grand jurisdictions, and such other duties as assigned. If any Brother is interested in this duty, please contact the Grand Secretary's office. It is a paid position, and would be ideal for a retired or semi-retired Brother who does not want a full time job. This Brother should reside in the Anchorage area.

All of you will never know how much he has done, and how much I truly appreciate him. We all owe him so much more than the customary round of applause, but let's give him that anyway. The other person I wish to thank is, of course, my wife Roxie. She and I spent over 10 hours going through the Index of the Alaska Masonic Code to make all of those additional entries into it. This was done over several evenings when she could have been doing something for herself. She also folded letters and stuffed envelopes for me on many occasions. Being left alone so many times while I was driving back and forth to Anchorage was tough on her, but still she smiled for me. She has been the true light of my life. Please, if you have a chance, stop by the table where she is outside the door and thank her for all the work she has done for this Grand Lodge.

Finally, I wish to say that it has been a great pleasure being the Grand Secretary, and I leave the office with mixed feelings. I have enjoyed the association with our Grand Masters and Grand Lodge Officers over the last two years, and I look forward to whatever post I am assigned to by our next Grand Master. Perhaps, after I am finally able to retire, I could be available for this office again if needed.

# RESOLUTIONS

## Carryover Resolution 2003-1

To Amend Sections 16.02, 16.03, 17.01, and 20.11 Bylaw  
To the Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska

**STATEMENT OF PURPOSE:** To make all newly raised Master Masons dues paying members and to eliminate contradictions between Section 16.02, Section 16.03, Section 17.01, and Section 20.11 Bylaws.

**RESOLUTION:** WHEREAS, those Master Masons raised in One-day Ritual Classes who pay dues, sign By-laws, and can hold all offices except Senior Deacon, Junior Warden, Senior Warden and Worshipful Master; and,

WHEREAS, the Master Mason raised in the traditional manner may attend Lodge, but must return proficiency prior to signing the Bylaws, paying dues, and holding any office;

NOW, THEREFORE, BE IT RESOLVED, that Section 20.11 of the Alaska Masonic Code which now reads:

### **Section 20.11 Bylaw**

**PROFICIENCY IN THE DEGREES.** A candidate may not be passed to the degree of Fellowcraft, nor raised to the Sublime Degree of a Master Mason without proof of proficiency in the preceding degree. This may be done by either:

1. memorization and recital of the Standard Proficiency as detailed in the Standard Work Cipher of this Jurisdiction; or,
2. by completion of a written Study Guide provided by the Grand Secretary as an education in Freemasonry and the memorizing and recital of the obligation of each degree as the Brother progresses through the degrees.

The choice of proficiency method shall be made by the Worshipful Master of the Lodge, and can be changed as the situation may dictate.

If option (1) is selected, the Standard Proficiency may be done by examination in open Lodge or by a committee appointed by the Master of the Lodge to examine such Candidate. If option (2) is selected, the completed written Study Guide is reviewed by the Master of the Lodge or a Committee of one or more members of the Lodge and if completed correctly the Brother is declared proficient by the Master and may progress to the next degree. The obligation of each degree must be given in accordance with the provisions in (1) above. The signs, tokens, and words must also be demonstrated at the same time.



After the Brother is declared proficient in the Degree of Master Mason by the Master of the Lodge, he must then sign the Bylaws of the Lodge and pay his dues for the current year. This may be done:

- (1) immediately following the examination if the Brother was examined in open Lodge: or,
- (2) at the next Stated Communication of the Lodge if the Brother was examined by a committee or if he selected the written Study Guide.

He then becomes an enrolled member of the Lodge. **(Section revised 1988, 1990, 1992)**

The provisions of this paragraph may be waived by the Grand Master for the purpose of conducting a "One-Day Ritual Class." (See Section 20.12)

Be amended to read:

**Section 20.11 Bylaw**

**PROFICIENCY IN THE DEGREES.** A candidate may not be passed to the degree of Fellowcraft, nor raised to the Sublime Degree of a Master Mason without proof of proficiency in the preceding degree. This may be done by either:

1. memorization and recital of the Standard Proficiency as detailed in the Standard Work Cipher of this Jurisdiction; or,
2. by completion of a written Study Guide provided by the Grand Secretary as an education in Freemasonry and the memorizing and recital of the obligation of each degree as the Brother progresses through the degrees.

The choice of proficiency method shall be made by the Worshipful Master of the Lodge, and can be changed as the situation may dictate.

- ~~2. — at the next Stated Communication of the Lodge if the Brother was examined by a committee or if he selected the written Study Guide.~~

After being raised as a Master Mason the Brother shall pay his dues for the current year as established in the Lodge bylaws and sign the bylaws.

He then becomes an enrolled member of the Lodge. (Section revised 1988, 1990, 1992)

**If at a later date he wishes to progress through the “Chairs” of his lodge he must demonstrate proficiency in the Master Mason degree in accordance with section 20.11 Bylaw paragraph 1 & 2 prior to being installed in the office of Senior Deacon, Junior Warden, Senior Warden or Worshipful Master.**

The provisions of this paragraph may be waived by the Grand Master for the purpose of conducting a “One-Day Ritual Class.” (See Section 20.12)

And, BE IT FURTHER RESOLVED, that Sections 16.02 which now reads:

**Section 16.02 Bylaw**

**QUALIFICATION TO VOTE, ELIGIBILITY TO OFFICE.** Each member in good standing of a lodge is entitled to vote, and is eligible to hold any office.

Be amended to read:

**Section 16.02 Bylaw**

Each member in good standing of the lodge is entitled to vote, and is eligible to hold any office **therein, except as restricted in Section 20.11**

And, BE IT FURTHER RESOLVED, that Section 16.03 which now reads:

**Section 16.03 Bylaw**

**Whereas**, the edict was put on hold by M.W. Cox at the direction of Judge Gleason, with the instruction that the matter be brought before this M.W. Grand Lodge at its Annual Communication in 2004, and

**Whereas**, this Grand Lodge has, and will for many years to come, suffer a huge financial loss through doubled insurance premiums as well as other incidental expenses because of the legal actions brought against this Grand Lodge and several of its officers, and

**Whereas**, all Master Masons have promised to abide by the Masonic Code and to live within its boundaries and limitations,

**Now therefore be it resolved**, that a new Section be added to the Alaska Masonic Code to read as follows:

### **Section 26.03 Civil or Legal Action.** Bylaw

Any Mason bringing a legal action and/or a civil lawsuit against the Grand Lodge, or any Grand Lodge member's actions for the Grand Lodge, without first pursuing due recourse through all provisions of the Alaska Masonic Code, will be immediately expelled from Masonry. Confirmation of the summary Expulsion will be taken at the next Grand Lodge session and will require a two-thirds affirmative vote of the members attending. If the expulsion is not upheld, the penalty will be lowered to Suspension for a time indefinite.

**Section 27.02 Bylaw**

**CITATION OR SUSPENSION.** If the Grand Master finds reasonable grounds for the filing of a complaint or charges against an officer of a Lodge, or a Mason of this Jurisdiction, he may, if the accused is an officer of the Grand Lodge or of a Lodge, suspend or depose him from the functions of his office; and he causes the accused to be cited by the Grand Secretary to appear and answer the complaint or charges at the next Annual Communication of the Grand Lodge following the expiration of twenty days after the date of service of such citation. Service of citation is made as prescribed by Section 29.05, or he may summarily suspend him.

If the Grand Master suspends the Mason or officer he shall then appoint a Grand Master’s Trial Committee in accordance with Section 32.02, and direct the Junior Grand Warden or another Grand Lodge officer to prosecute the case before the Grand Master’s Trial Committee. The accused shall have all the rights of defense as in Section 30.02. The trial shall be held within 60 days of the suspension, but at least after the expiration of twenty days following service of citation. The results of the trial shall be sent to the Lodge or Lodges in which the Brother is a member, and reported in full to the next Annual Communication of the Grand Lodge.

**WHEREAS,** some lodges and or their holding companies have found it necessary to rent or lease properties under their control to concordant bodies or members thereof or to outside individuals, companies or groups to generate revenue and

**WHEREAS,** on occasion alcohol may be served or consumed on these premises and

**WHEREAS,** there is a very real liability from incidents that may occur after someone consumes alcohol on these premises and

**WHEREAS,** these liabilities may have grave consequences to the Grand Lodge of Alaska and all of its officers and members

**Therefore be it resolved,** that the Alaska Masonic Code Section 12.04 Bylaw be Amended to read, (changes underlined)

Section 12.04 Bylaw

**INTOXICATING LIQUORS IN THE LODGE ROOM.** Intoxicating liquors shall not be introduced into a Lodge Room. Lodges or Temple Corporations may, at their option by Standing Resolution, adopt and enforce such regulations relating to other areas than a Lodge Room as they, in their wisdom, may deem appropriate.

If said Lodges or Temple Corporations or Holding Companies choose to allow a function, by individuals, parties, or an organization where alcohol may be served or consumed on properties under their control, they must have a liability insurance policy on file with the Grand Lodge of Alaska in the amount of \$2,000,000.00 (two million dollars) expressly covering the serving or consumption of alcohol at such event. This policy must state that the Grand Lodge of Alaska and all its members and constituent Lodges, and /or concordant bodies are insured against any incident that may occur from the serving or the consumption of alcohol on said premises.

Lodges or Temple Corporations may, at their option by Standing Resolution, adopt and enforce such regulations relating to other areas than a Lodge Room as they, in their wisdom, may deem appropriate.

If said Lodges or Temple Corporations or Holding Companies choose to allow a function, by individuals, parties, or an organization where alcohol may be served or consumed on properties under their control, they must have a liability insurance policy on file with the Grand Lodge of Alaska in the amount **of a minimum of \$1,000,000 (one million dollars)** expressly covering the serving or consumption of alcohol at such event. This policy must state that the Grand Lodge of Alaska and all its members and constituent Lodges, and /or concordant bodies are insured against any incident that may occur from the serving or the consumption of alcohol on said premises.

**This resolution was amended on the floor of the Grand Lodge. The amendment was passed. This amended resolution received the required three-fourths majority vote and was adopted.**

## **Resolution 2004-5**

**To the Most Worshipful Grand Lodge of Free and Accepted Masons of Alaska:**

**STATEMENT PURPOSE:** To clarify the procedure for changing the Bylaws for a Lodge

**WHEREAS,** there has been some confusion as to the normal course of events in effecting a change to the Bylaws of a Lodge, and

**WHEREAS,** the procedure should one that is smooth and free of potential hang-ups in pursuing the desires of the members of the Lodge,

**NOW, THEREFORE BE IT RESOLVED,** that Section 15.02 Constitution which now reads:

Section 15.02 Constitution

**Lodge Bylaws.**

1. A Lodge has the power and authority to enact bylaws for its own government which are not in conflict with the Constitution or Bylaws of the Grand Lodge or with the principles of Masonry.
2. Bylaws can be adopted or amended only at a Stated Communication by a two-thirds majority vote of the members present after written notice of the proposed action has been mailed to each member of the Lodge at least ten days prior to the Stated Communication.
3. When adopted, the new Bylaws or amendment is sent in duplicate to the Grand Secretary for referral to the proper committee(s) and then to the Grand Master, or directly to the Grand Master, as appropriate.
4. When approved or disapproved, one copy is returned to the Lodge and one copy is retained in the Grand Lodge files.
5. The Bylaws and amendments thereto become effective when approve by the Grand Master. (Section revised 1989)

**Be amended to read:** ( change underlined para. 2 only)

2. Proposed Bylaws or amendments thereto are presented in writing at a Stated Communication. Bylaws can be adopted or amended only at a subsequent Stated Communication by a two-thirds majority vote of the members present after written notice of the proposed action has been mailed to each member of the Lodge at least ten days prior to the Stated Communication.

## 2nd Report

(No written report-but taken from tape recording of the Grand Lodge Communication)

To the Most Worshipful Grand Lodge of Free & Accepted Masons of Alaska.

The following issues were referred to the jurisprudence committee for consideration during the year of 2003 and previous to the 2004 Grand Lodge Communication (and as I said the Grand Master asked me to give this report, I hadn't given one of these before.. I didn't remember all of the actions that we , the questions that came before us but I tried to remember the most recent ones).

I should reference a letter dated 10/29/2003 from the special deputy RW Jerry Fairley regarding procedural questions in the forfeiture of Anvil Lodge Charter. In my letter response dated 11/06/2003 that it was recommended that the proper procedures were followed by the lodge and the brothers voted to forfeit the charter, then all the efforts to assist them in initiating demits and affiliations should begin immediately. In the event this becomes impossible then it would be wise for the Grand Lodge to inform the brothers that they should merge or consolidate with the lodge of their choice if and when agreed upon by both lodges. There was no formal meeting of the jurisprudence committee on this issue but that they have reviewed my report and the jurisprudence committee is unanimously in favor of the report.

In October 2003, a brother of Matanuska 7, via a teleconference, requested a ruling regarding the Lodge's investigation of a brother prior to his being voted upon as a dual or affiliated member of his lodge. He was given reference to Section 17.04 Bylaw of the Alaska Masonic Code which states that the petition for affiliation must take the same course as the petition for the degrees.

On 12/04/2003, a request was made by teleconference by RW Jerry Fairley and MW Brother Stan Foulke for determination regarding the rules of order when voting in front of the resolution regarding the forfeiture of the charter of Anvil Lodge. Section 25.02 refers to this procedure, argued by MW Foulke, that if it were not seven persons present wishing to retain the charter, then those present (I believe there were five) must vote on the issue and the majority should prevail which was in accordance with his interpretation of Section 7.04 of the Alaska Masonic Code. That section of the Alaska Masonic Code strictly deals with Part 1 Grand Lodge, Chapter 7 Rules and Order of Voting, Section 7.04 Bylaw Voting, specifically states "Motions on Grand Lodge are determined by majority vote except as may otherwise be specifically provided."

The Section which contains constitutions and bylaws covering constituent lodges as in Part 3 of the Alaska Masonic Code, Constituent Lodges, Chapter 14, Section 14.04 Bylaw is the only reference to voting procedures other than those issues that have specific sections and guidelines to follow. There is no reference made in the Alaska Masonic Code pertaining to constituent lodges and requiring a majority vote on a motion to

surrender their charter of for that matter any motion that comes to the floor of the lodge. It might be assumed that a majority vote upon a motion is a rule and guide unless otherwise stated by appropriate law but there is no written law under Part 3 Constituent Lodges stating that fact and thereby any lodge that would wish to make a law stating that ninety percent affirmative vote required to pass a resolution or motion in their lodge could do so without being in conflict with the Code. In fact, there are areas in Part 1 Grand Lodge and Part 3 Constituent Lodges which indicate a very different majority vote upon the same issues with their individual jurisdictions. Reference Part 1 Grand Lodge, Section 7.07 Constitution, bylaw changes require a  $\frac{3}{4}$  majority vote to pass in Grand Lodge. Reference Part 3 Constituent Lodges, Section 15.02, paragraph 2, Lodge bylaws changes require a  $\frac{2}{3}$  majority vote to pass.

The point is, the sections refer to procedures in Grand Lodge and individual lodges. The end result of that conversation was agreed that a withdrawal of the motion to surrender the charter be executed and a motion to consolidate be put before the membership for approval.

On 12/04/2003, a request for a determination as to whether the motion to forfeit the charter by the brothers of Anvil Lodge could be withdrawn. It was stated that, of course, like we said in the agreement that it was stated by the chairman of the Jurisprudence Committee .....Noise on tape.....that they are less important along with the ancient usages and customs of the fraternity throughout the world and the ancient landmarks which they dictate the Grand Master's powers. More specifically, his powers to rule and govern the Masons within this jurisdiction and answering only to the Grand Lodge of Alaska when convened. It is most definitely confined within the text of the Alaska Masonic Code. This issue was not agreed upon to be stipulated in the test of an agreement made between the authority of the Grand Lodge of Alaska and VW Brother Fulton and W Brother Summers in December of 2002, arbitrated by their council before the civil courts of Alaska and in accordance with the authority of this Grand Lodge, and those two brothers that the following report that you will see being submitted. That is in accordance with that agreement and the information contained within that agreement and the information that report contained will also be pointed out when I read those reports.

## **Finance**

### **Report of the Grand Treasurer**

To the Most Worshipful Grand Lodge of Alaska, F. & A. M.

I herewith submit my report of the financial status of this Most Worshipful Grand Lodge.

The year 2003 has shown a marked increase in the accuracy of the financial records of your Grand Lodge and to the efficiency of its office:

- A new accounting system (Peachtree Complete) was implemented providing a highly sophisticated capability that should be adequate for our use for years to come.
- Our method of accounting was converted from a cash basis to an accrual basis, thereby permitting a more accurate association of revenue received with the expenditure of those funds.
- Correction of several entries made in previous periods reflects our greater accuracy.
- Depreciation of our fixed assets was calculated to reflect the fact that these assets are showing the wear and tear associated with use, and that they will have to be replaced at some future date.
- Interest and dividends on investments have been recorded to more properly reflect the value of those investments. As can be seen from the notes to the attached financial statements, this amounted to a substantial increase in the book value of those assets.
- Numerous cost reducing and/or efficiency enhancements have been made in the Grand Lodge office's operations. Foremost are the new Grand Lodge forms CD, the dues card preparation process, and the forthcoming Masonic Code with enhanced index. Most of these were developed by the Grand Secretary, and will help both his office and the individual Lodge Secretaries.
- Many other changes have been made, and hopefully they will add to the accuracy of our financial records, to the efficiency of the Grand Secretary's and Grand

Treasurer's Office and to the ability of each Brother to understand the information the reports contain.

Additional changes and improvements will probably be made in the next few years.

This last year has been an interesting one, and I particularly appreciated the opportunity to work closely with our Grand Secretary. But the changes that have been made (especially those of a technical accounting nature) could not have been made without the assistance S.M. (Mike) Johnston and M.:W.:Gunnar Flygenring. These two Brothers have been a constant fount of accounting wisdom, and have always been ready to answer questions or give advice.

I must give recognition and thanks to my wife, Sharon. She is my "Corporate Grammarian", and has put up with my many absences from home. I could do nothing without her.

Finally, the attached financial statements are, to the best of my ability, a proper reflection of the current status of the financial affairs of this Grand Lodge.

### **Notes to Financial Statements**

1) The Original cost basis for the NBA/Wells Fargo stock was \$1,330.00. For the past two years since NBA merged with Wells Fargo, we have received information advising that we have been credited the following interest amounts:

However, because the original stock certificates have been lost, and therefore ownership is in question by the Stock transfer agent, we have not actually received the reported dividends on this stock. Consequently, the dividend have been recognized as income and added to the cost basis of the original NBA stock basis, resulting in a total cost basis at December 21, 2003, of \$3,921.12. Additionally, the converted NBA stock with an estimated market value of \$58,000.00 has not been issued to the Grand Lodge pending the resolution of the lost stock certificate matter.

2) Total investment cost basis in the following accounts was adjusted by the amounts indicated to compensate for accumulated dividends, interest income, and gains & losses on securities transactions reinvested in prior years.

In as the income was reported for tax purposes and recognized on investments schedules in prior years it was not always booked to the permanent records. Therefore, the General Fund investments were understated by \$100,820.79, and the Life Membership Fund was overstated by \$2,439.67. adjustments correcting the balances have been booked to the records at December 31, 2003.

Formerly the broker monthly and annual statements showed only market values, and rendered no cost basis scheduling. With the new annual reporting statement showing all investments at original cost, we now have a way to positively verify our invested cost basis at the year end.

## Masonic Youth and Public Schools

Report of the Committee on Masonic Youth and the Committee on  
Public Schools

The following is a report of the activities of the Most Worshipful Grand Lodge of Alaska Public Schools Committee and Masonic Youth Committee for the year 2003.

This past year the Chairman of the Masonic Youth Committee (Stanley L. Woodin) and Public Schools Committee (John R. Cline) joined together to survey the constituent lodges in the Grand Lodge of Alaska on their participation in support of Masonic Youth (DeMolay) and the Public Schools of Alaska (see attached). The purposes of the surveys were to assess the kinds and amount of support the lodges provide, to recognize their contribution, and to baseline that support so that future improvement could be quantified. All 22 constituent lodges in the Grand Jurisdiction of Alaska were mailed questionnaires along with pre-addressed return envelopes. Of the 22 lodges, seven (7) or about 1/3 responded. Following is a synopsis of the information requested and the data received.

**Masonic Youth:** The lodges were asked if they sponsored a DeMolay chapter and, if so, its name, status, and advisor's name. Additionally, they were asked if they sponsored any other type of youth organization, and, if so, what type of organizations and the name of the lodge member who represented the lodge to the organization. Of the seven lodges who responded, only two reported that they sponsored a DeMolay chapter. In one case the chapter was reported to be inactive. While in the other, the chapter was reported to be only somewhat active. Regarding other types of youth groups sponsored, one lodge reported that it sponsored a Cub Scout Pack, while another lodge reported that it sponsored both a Rainbow Girls' Assembly and a Jobs Daughter's Bethel. The attached spreadsheet of Masonic Youth Activities summarizes the responses received.

Additionally, the lodges that responded stated that several of their members were active volunteer participants with the Boy Scouts of America at the District and Council level.

**Public Schools:** The lodges were asked if they sponsored a scholarship program and, if so, what was the basis of the scholarship, were scholarships given out in 2003, how much money was awarded, and if the scholarship was covered by a 501 c(3) tax exempt status. Additionally, they were asked if they sponsored an academic award program and, if so, the type of recognition awarded and if the lodge presented awards in 2003. Of the seven lodges responded, four reported they sponsored a scholarship program, however, one of these programs was new and had not yet raised enough money or returned any to the community. Two of the scholarship programs were covered by 501 c(3) tax exempt status. A reported \$33,000 was raised and \$38,500 awarded in scholarships in 2003. Of particular note is the Mt. Juneau-Gastineaux Lodge, who contributed the bulk of the scholarship money (\$33,000) in 2003. Three of the seven lodges reporting stated that they supported a non-monetary recognition program, two of which were active in 2003.

In addition, the lodges that responded stated that some of their members were either currently active or are retired educators who remain active as substituted teachers.

Geography (Time, one hour)

5. Name and describe the following: Monrovia, Odessa, Denver, Manitoba, Hecla, Yukon, St. Helena, Juan Fernandez, Aspinwall, and Orinoco.
6. Name and locate the principal trade centers of the U.S.
7. Name all the republics of Europe and give the capital of each.
8. Why is the Atlantic Ocean colder than the Pacific in the same latitude?
9. Describe the process by which the water of the ocean returns to the sources of rivers.
10. Describe the movements of the earth. Give the inclination of the earth.

Notice that the exam took FIVE HOURS to complete. Gives the saying “he only had an 8<sup>th</sup> grade education” a whole new meaning, doesn’t it?! Also shows how poor our education system has become.

## Bylaws

### Report of the Committee on Bylaws

During the Masonic Year 2003, The Committee on Bylaws received the following two (2) amendments to Lodge Bylaws for consideration – in accordance with Section 15,02 – Constitution – entitled Lodge Bylaws

1. From **White Pass Lodge No. 1** relative to change of date and time of the Stated Communication of the said Lodge – i.e. from 7:30 p.m. on the third (3<sup>rd</sup>) Tuesday of **each** month to the third (3<sup>rd</sup>) Saturday of the months of January, March, May, September, October, and November **only** and at the hour of 12.01 p.m.
2. From **Iditarod Lodge No. 20** relative to change of months only of the Stated Communication of the said Lodge from **each** month to ten (10) only – i.e. the months of July and August to be “dark” – with the hour of the Stated Communication remaining the same (7:30 p.m.).

We the Committee on Bylaws, found that in each instance a sufficient number of votes were cast in favor of the said amendments. We, however, found, that while the ‘proper’ procedure with respect to notification of the membership was followed in the first case (White Pass Lodge No. 1), the ‘**proper**’ procedure in the latter case (Iditarod Lodge No. 20) was not followed – i.e. there is no evidence that the proposed amendment to the Bylaws of Iditarod Lodge No. 20 was presented to the Lodge at a **prior** Stated Communication (than the one at which the vote was taken), although mail-out notification appeared to have been made in a timely fashion – i.e. at least ten (10) days prior to the Stated Communication at which the vote was to be taken.

We, the members of the Committee on Bylaws, therefore recommend to the M.W. Grand Master the approval of the above mentioned amendment from White Pass Lodge No. 1, while we recommended that the latter amendment from Iditarod Lodge No. 20 be **not** approved. To the first request for change to Lodge Bylaws – i.e. from White Pass Lodge No. 1 – all the members of the Committee affixed their signatures, while in the second instance – i.e. from Iditarod Lodge No. 20 – only three of the four members affixed their signatures, while the fourth member concurred ‘telephonically’ in the decision to recommend that this requested amendment be **not** approved.

## **Report of Grand Orator**

Most Worshipful grand Master, Right Worshipful Grand Lodge Officers, distinguished visitors, Brothers All

When asked by the Grand Master to accept this appointment as Grand Orator, I thought immediately of having to present a very long address. Fortunately, the Grand Master said he would allow me only 7 to 10 minutes. He must have had second thoughts as to how good a speaker I am.

In Blue Lodge, after the first degree has been conferred to the candidate, the Worshipful Master informs the newly made Entered Apprentice what he may and may not do, along with the lodge room disciplines. Included is the proper form or attitude for attending prayer – left hand over the right with the response “So Mote It Be.” The words “So Mote It Be” are the last words written in the Regis Poem, or more accurately stated, the Regis Manuscript, written about 1390.

While reading, I came across the Harlein Manuscript, written about 167-. The Harlein Manuscript is a newer version of the original Regis Manuscript, and retains the same Masonic Landmarks and features of the 1390 writing.

This version (The Harlein Manuscript) came into being about the same time that Non-operative or “Speculative Masons” were being admitted into the fraternity. It reads as follows:

1. The Master Mason must be steadfast, trusty and true and render perfect justice to both his workmen and his employer.
2. The Master Mason shall be punctual in his attendance at the general congregation of assembly.
3. The Master must take no apprentice for less than seven years.
4. The Master must take no apprentice who are bondsmen but only such as are free and well born.
5. The Master shall not employ a thief, or a maimed man for an apprentice, but only those who are physically fit.
6. The Master must not take craftsman's wages for apprentice's labors.
7. The Master shall not employ a thief or immoral person.
8. The Master must maintain a standard of efficiency by not permitting incompetent workmen to be employed.
9. The Master must not undertake to do work which he can not complete.
10. No Master shall supplant (trip up by treachery) another in the work undertaken.
11. The Master shall not cause the masons to work at night except in the pursuit of knowledge.
12. No mason shall speak "evil" of his fellows work
13. The Master must instruct his apprentices in everything they are capable of.
14. The Master shall take no apprentices for whom he has not sufficient labor.
15. The Master is not to make false representations, nor compromise any sin of his fellows.

We can see where these landmarks with one or two exceptions may be applied to either Operative or Speculative Masonry.

These landmarks influenced the forming of the Grand Lodge of England (1717) and have been part of all Grand Lodges and Blue Lodges since then. They have helped to set the course and enabled the development of modern day Masonry as we know it, because they were well thought out for that particular time of change and turmoil.

Of course over time each Grand Lodge, and Blue Lodges within individual Grand Lodge Jurisdictions, set their own landmarks. We really are not thinking of landmarks, though, when we institute resolutions, like we will or have done during this and other Grand Lodge sessions. In time, history will tell if the decisions we make will be of landmark status.

We are a young Grand Lodge, only having been chartered since 1981. as a young Grand Lodge we are still having growing pains, wrought with the problems of retention, growth, and internal turmoil. Are we stumbling and creating landmarks of the wrong kind, unknowingly?

I remember the Worshipful Master standing me in the NE corner of the lodge many years ago as the youngest Entered Apprentice Mason, charging me "to ever walk and act as such."

We all should look back to those moments in time. We all need to revisit and keep faith with the obligations we took at the Altar, as we progressed through the degrees. Our Personal Landmarks!

We are looking for ways to increase membership, often thinking of taking short cuts such as lowering proficiency methods, one-day classes (fast tracking) or not learning the work properly to progress through the degrees.

All of our Lodges are having attendance problems. We need to find a way to solve this problem.

We find that to keep our Lodges alive we are recycling Past Masters back to the East, and in some cases fast tracking brothers to positions they are not ready for. We have to ask ourselves, are we driving out new and old brothers who just want to come to lodge for the fellowship, and not be asked or intimidated into taking a position, no matter how small.

Some lodges struggle to put on degree work only to see the newly made Mason fall by the wayside because we have no brothers willing to take on the task of working with him. Whose fault is it? On the bright side, we have some very dedicated brothers working hard to turn this around. But they need help.

In years past I have attended meeting called by the District Deputy of the Grand Master. On occasion attendance by Lodge officers and members has been very poor. The purpose of these meetings is to discuss problems within the lodges and to find solutions to them. When called upon, we need to attend and help resolve problems within the Lodges.

We all need to reacquaint ourselves with the ciphers, so as not to become rusty Master Masons before our time. We need to attend lodge practices. You will be helping yourself and your Lodge.

The brothers participating in degree work need to start picking up the book at home and studying their parts. Don't wait until you get to Lodge to do that. Attend practices; sloppy degree work leaves a poor impression on the candidate.

Officers, elected and otherwise, learn your parts and don't depend on the cipher to get you through the work when you get to Lodge. That sets a bad example and encourages everyone else to do the same. Even if you make mistakes, you will still be learning the work, and the effort you are putting forth will be obvious to all the brothers, and will be appreciated.

What we do, and how we act in the Lodge room, affects the future of our Lodges. Some issues being discussed are often just beat to death with no resolution having been achieved. They are hashed over and over and over with no end in sight. I know of at least one brother who won't come to Lodge due to that. He thinks it's a waste of his time! Is he right?

There are those who believe that to come to Lodge you are required to wear a suit and tie. There is no doubt that when you come to Lodge dressed nicely you probably will feel better about yourself and be more inclined to help out and perhaps do better work yourself. This is fine if you are able to. Do each of you remember how you were first received in the Lodge as an Entered Apprentice?

The January – February issue of the Scottish Rite Journal has an article in it concerning one-day classes that were held in Ohio. I hope all of you have an opportunity to read it as it gives a lot of the pro's and con's concerning that method of acquiring new members. It is interesting that one year later after having raised 7,700 new Master Mason in a statewide one-day class, a survey was done. Here are two statistics of interest from that survey.

Of the total 7,700 new Master Masons who were made, 91% said that the shortened time was important for them in having received the degrees. Some 69% said “the removal of the memory work, and examinations” was important.

Remember, we will in part be making the landmarks for this Grand Lodge when we vote to adopt resolutions and effect change. We need to think of how, and in what favor, these landmarks will be looked upon in the distant future.

Our personal landmarks are the cornerstones of Masonry in this Grand Jurisdiction, both in and out of Lodge; we should ever “walk and act as such” by their direction.

Most Worshipful Grand Master, I thank you for allowing me to address this Grand Lodge Session, and submit this written copy to the Grand Lodge, that it may be accepted as presented.

## **Report of Grand Historian and Alaska Masonic Library and Museum**

Brothers:

History is a hard subject, and at times almost impossible to keep up. We do not have the means to record all things that happened throughout the Grand Lodge and individual lodges without some kind of access to all of the records. I caution everyone. Adversity has a tendency to drive away brothers and new candidates, when we desperately need a working membership. Remember the working tools, most especially the trowel. A divided house most often fails. We don't need others trying to get us to choose sides, one against another, Think about it and do the right thing. Stay together and stay strong.

Enough said. Now, onto something else.

## **ALASKA MASONIC LIBRARY AND MUSEUM**

This is the third year in a row during which the Alaska Masonic Library and Museum has seen remarkable progress. The first year we were allowed to use space in the building at 4<sup>th</sup> Avenue and F Street. Within a year, we expanded beyond the wall of our allotted space. We started with five or so books, some copies of the proceedings of our Mother Jurisdiction and boxes of miscellaneous items. We now have an office with computer, printer, file cabinets, display cases, book cases filled with hundreds of Masonic and non-Masonic books, pamphlets, and other publications of interest. Even with his busy schedule, Jerry included a trip to Kenai to pick up items donated from MW Ingram's estate, and a trip to Nome for the possible closing of Anvil Lodge No. 2, to transport many boxes of items for the museum to Anchorage. These items, along with donations coming from other Brothers, or widows of departed Brothers, have filled our space until we, again, had to ask for more room. Our cup runneth over, yet this is just the tip of the iceberg. There is much more that needs to be brought in, so all can share in

learning about ourselves. Please heed the call for MORE LIGHT, and see if there isn't something in your garage, attic, crawl space, or other storage area just going to waste, that could be donated to the Alaska Masonic Library and Museum, to share with all present and future brothers, sisters, and other visitors. We also accept financial donations. Don't forget the Foundation has been designated an IRS 501 c (3) organization, and all donations are tax deductible.

We again invite each of you to visit your Library and Museum. We feel that you will be quite pleased with what you find. The Curator's normal hours are 10:00 A. M. till 3:00 P.M. ### **Report of the Russian Relations Committee**

There is continued interest among Masons in the activities of the Grand Lodge of Alaska's Relations Committee. Correspondence and Lifetime membership applications have been received from Australia, Brazil, Bulgaria, Canadian Providences, France, Germany, Greece, India, Ireland, Netherlands, Romania, Scotland, and Ukraine.

The new lodge in Vladivostok started by the Grand Lodge of Alaska is located over 5,200 miles from Moscow. This is twice the distance from Seattle to New York. The lodge is closer to Alaska than Moscow.

In 2003, the Russian Relations Committee has assisted the new lodges in Eastern Russia to expand and to initiate new candidates.

Alpha & Omega Lodge #23 in Novosibirsk is having problems finding an affordable place to meet. Our committee sent the A & O Lodge two payments of \$800 so they could rent a place to initiate new candidates. The lodge is now responsible for their rental expenses.

Pacific Rim Lodge in Vladivostok is also gaining in new members. They have a well-furnished lodge room with rent covered by Lodge members. Our committee sent the lodge \$600 to assist in the furnishing of their new lodge room. They now have a new Masonic altar \$120, 10 new chairs \$221, three stations for the officers \$214, shades, curtain rails, lamps, flags, etc. \$116. Monthly rent for the lodge room is \$40. The secretary is very frugal in his spending. Lodge members furnish labor. Retired elderly ladies in Vladivostok made a new altar apron. Masons from Maine have donated funds for the altar apron.

Pacific Rim Lodge #567 in Long Beach, California wrote that they would like to send something to Pacific Rim Lodge #12 in Vladivostok. They asked what would the Russian Lodge desire? The answer was, "An American Flag." An American flag was subsequently donated by the California lodge.

April 2003 – WM Sergei Bogolepov writes: Yes we believe Alenandr from Tomsk can attract enough qualified candidates to establish a lodge there. My task is to encourage

him to reach out and find prospective candidates. I have some prospective people in other cities, but in this point they are in hesitation. You can't win people just sending them some booklets. Good personal contact is a must. I want to share this good news with my Brothers who are supporting me in my works.

Income for committee expenses depends on a one-time Lifetime membership fee. Lifetime membership in one of the Russian Lodges, sponsored by the Grand Lodge of Alaska, is \$200.

It is heartwarming to experience the enthusiasm of qualified candidates that have joined the brotherhood of Freemasonry in Eastern Russia.

We would like eventually to challenge the members in Novosibirsk to mach a grant to purchase a building to be used as a lodge hall. Bu7t this will have to wait for a later date.

Primary goal this year is to start another lodge in Tomsk in Eastern Russia. We will aos assist the two current lodged to develop to become proficient in their work. Once this is accomplished, the new lodges will be prepared tostart spreading Freemasonry in Eastern Russia.

## **Wills and Endowments**

### Report of the Wills and Endowments Committee

Recommendations of the Wills and Endowments Committee:

1.) To form a Masonic Charity Foundation to provide a conduit for charitable giving through several types of annuities which can benefit both the Grand Lodge and the individual donor in tax benefits and guaranteed income.

**Tax benefited contributions** can be made in various ways:

*Current gifts* such as cash can produce immediate income tax savings.

*Deferred or planned gifts* can also produce current income tax savings. For example, the donor might make a commitment to contribute assets after death while retaining the right to receive income from the property during his lifetime. For some donors this offers the best of both worlds – tax savings in the present without giving up current income.

*Gifts of income* refer to property which is given back to the donor or his family after a period of time, which may result in tax savings.

*Gifts* may also be made which produce only estate tax savings.

**Pooled income fund** is an account which is much like a shared mutual fund.

**Gifts of real estate** or other property.

**Life insurance** may provide an attractive method of charitable giving, and is a method which is often overlooked. The gift of a policy results in an immediate charitable deduction. If the policy is paid up, the deduction is the amount of the replacement value, but not more than the cost basis (usually the total of all the premiums paid, less any dividends received.) If premiums are still being paid, the deductions will be roughly equal to the cash surrender value. After the gift is complete, the donor may make additional annual, deductible cash gifts to enable the Grand Lodge to pay each year's premium. Life insurance contributions are particularly attractive when the donor's family is grown, and insurance may be of less importance. There are estate tax advantages as well, since the proceeds of a donated policy will not be included in a donor's estate.

2.) To allow approved certified charity advisors to make presentations on individual lodges and their membership in order to educate and solicit funding on behalf of the Grand Lodge. A C.C.A. designation is an independent professional consultant who provides individual donors and non-profit organizations with consulting services that help these organizations obtain capital through funding strategies or planned giving programs.
